The final policy will have very clear cut decisions with regards to 5/20 rule. There will be no ambiguity in this regard."

While our domestic sector is booming, the growth of international sector is a little less at around 12 per cent. But, it still is very high as compared to most of the countries. We are currently facing the challenges of growth, and I am glad that we are meeting these challenges very well."

What is 5/20?

The 5/20 rule, in its meaning, restricts companies from flying abroad unless they have flown in India for five years and have a fleet size of 20 aircraft
